Animal Humane Society's Veterinary Centers provide low-cost spay/neuter surgeries and full-service veterinary care on a sliding fee scale, expanding care to animals whose options would otherwise be limited. In September 2020, we opened a new public veterinary center in St. Paul, MN to expand these efforts.

In the year ended June 30, 2022 our vet centers provided 6,063 spay/neuter surgeries and 5,768 exams, wellness visits, dental, and specialty services.
